## NURSERY STOCK AND PLANT PEST CONTROL (SDCL 38-24B)

#### **DESCRIPTION OF CLASSIFICATIONS**

**RESIDENT NURSERYMAN:** Grows all or a portion of the nursery stock he sells.

**NURSERY STOCK DEALER:** Who is not a resident nurseryman:

- 1. Who buys nursery stock for the purpose of reselling or reshipping;
- 2. Who makes landscape plans using nursery stock and negotiates in the purchase of nursery stock for his clients; or
- 3. Who contracts to furnish and plant nursery stock.

**OTHER:** Any grower of sod, decorative, annual, or related plant products who wants certificate of inspection.
