## NOTICE OF TOTAL MAXIMUM DAILY LOAD ADDENDUM DOCUMENT: AN OPPORTUNITY FOR PUBLIC COMMENT

The South Dakota Department of Agriculture and Natural Resources (SD DANR) is announcing the availability of the following Total Maximum Daily Load (TMDL) addendum for review and comment.

## ESCHERICHIA COLI (E. coli) ADDENDUM TO THE FECAL COLIFORM BACTERIA TOTAL MAXIMUM DAILY LOAD (TMDL) FOR WILLOW CREEK SEGMENT 01, DEUEL AND CODINGTON COUNTIES, SOUTH DAKOTA

Public involvement is a required component of TMDL development in accordance with section 303(d) of the federal Clean Water Act.

SD DANR adopted *E. coli* criteria to protect waters designated recreation uses (Administrative Rule 74:51:01: 50:51). *E. coli* replaced fecal coliform as the primary bacteria indicator. The 2024 South Dakota Integrated Report for Surface Water Quality Assessment identified Willow Creek segment 01 (**SD-BS-R-WILLOW\_01**) as not supporting the designated limited contact recreation use due to increased levels of *E. coli* bacteria. As a result, this segment was placed on the 303(d) list of impaired waterbodies and requires a TMDL for *E. coli*. A fecal coliform TMDL was approved by the US EPA for Willow Creek-Segment 01 in 2008 (TMDL ID# 34507).

*E. coli* is a fecal coliform bacteria and both indicators originate from common sources in relatively consistent proportions. The similarity in both bacteria provide an avenue to convert the existing fecal coliform TMDL and allocations to *E. coli*. This draft TMDL intends to convert the existing fecal coliform TMDL to *E. coli* to address the bacteria impairment using an addendum process. The TMDL establishes the *E. coli* loading required to bring the waterbodies into compliance with applicable water quality criteria. The *E. coli* TMDL and allocations follow the assumptions established in the 2008 fecal coliform TMDL.
