A motion was made by Charlie Moe and seconded to deny Day Conservation District request to amend the budget of grant #2012-CSW-010 (Northeast Glacial Lakes Watershed Improvement & Protection Project). Request was to change the percentage of Commission grant funds from 30% to 50% with matching grant funds of 50% from their EPA 319 Clean Water grant and eliminating the Day Conservation match contribution of 20%. Their request was denied because the commission felt that the district must furnish cost-share. **Motion carried.** Doug Hansen abstained.

A motion was made by Aaron Kiesz and seconded to approve Hanson County Conservation District request for a 1 year extension for grant #2014-CSW-012 (Hanson County Shelterbelts). **Motion carried.**

A motion was made by Charlie Moe to deny Butte Conservation District request for extension and transfer \$10,181.09 of unobligated funds from travel to scholarships and travel for state competition or travel for a possible regional competition in Kansas for grant #2013-CSW-006 (SD Envirothon Pilot Project). The request was denied as the commission felt there was a need for clarification of the events and a new budget explaining how the funds would be used. The commission suggested that the district come back at the May meeting with a new request. **Motion carried.**
