Bentonite Performance Minerals, LLC has submitted the Request for Determination of Special, Exceptional, Critical or Unique Lands and Notice of Intent to Operate for purposes of determining whether the lands potentially affected by the proposed mining operation are eligible for inclusion on the preliminary list of special, exceptional, critical, or unique lands.

The proposed operation involves mining for bentonite on land approximately two miles northwest of Belle Fourche, South Dakota. Reclamation will be conducted concurrently with the mining operation. The land will be reclaimed to its present use of rangeland.
