

**NOTICE OF REQUEST FOR DETERMINATION OF SPECIAL,
EXCEPTIONAL, CRITICAL OR UNIQUE LANDS
BENTONITE PERFORMANCE MINERALS, LLC**

Notice is hereby given that Bentonite Performance Minerals, LLC, 554 U.S. Highway 212, Belle Fourche, South Dakota 57717, has submitted a Request for Determination of Special, Exceptional, Critical or Unique Lands and Notice of Intent to Operate to the Department of Agriculture and Natural Resources for a bentonite mining operation. The legal description of the operation is Portions of Sections 31 and 32; T9N-R2E, Butte County. Bentonite Performance Minerals, LLC has submitted the Request for Determination of Special, Exceptional, Critical or Unique Lands and Notice of Intent to Operate for purposes of determining whether the lands potentially affected by the proposed mining operation are eligible for inclusion on the preliminary list of special, exceptional, critical, or unique lands.

The proposed operation involves mining for bentonite on land approximately two miles northwest of Belle Fourche, South Dakota. Bentonite Performance Minerals, LLC will affect approximately 128.4 acres during the life of the Security Mine. Several pits will be mined using cast back mining techniques. Topsoil, subsoil, and overburden will be stripped and stockpiled or used to backfill and topsoil previously mined pits. Bentonite will be hauled from each pit along existing haul roads to Bentonite Performance Minerals LLC's processing plant in Colony, Wyoming. Reclamation will be conducted concurrently with the mining operation. The land will be reclaimed to its present use of rangeland.
