RE: Seed mix concurrence request for notice of intent to conduct mineral exploration

Dear Ms. Syversen:

American Colloid Company is in the process of preparing a Notice of Intent to conduct mineral exploration for submittal to the SD Department of Agriculture and Natural Resources (DANR). State statute requires consultation with the NRCS as part of this application/approval process. A seed mix concurrence letter from your office is required for the DANR to deem the application Complete.

The exploration areas are located approximately northwest Belle Fourche between Highway 212 and in proximity to 3V Road to the Wyoming/South Dakota state line.

Proposed Activities: Exploration will consist of auger drilling to obtain a small amount of mineral for analytical purposes. Maximum depth of drilling will be approximately sixty feet. Drill holes will be placed (augured) on a grid pattern of approximately 150' X 150' between placement of holes. Exploration will be conducted, weather permitting. Access to and throughout the proposed exploration area will be via existing roads and trails. Limited off-road sampling will be conducted. Off-road sampling will be conducted in such a manner as to not cause any significant surface disturbance. No roads will be constructed during this operation. Exploration and drilling will be conducted using a four-wheel drive truck, with a rear mounted, auxiliary powered, auger drill.

Reclamation of all Disturbances: Reclamation of all disturbed areas will be completed immediately after sampling. All cuttings and materials extracted from the drill hole will be placed back into the drill hole followed by seeding the disturbed areas. ACC will take all reasonable measures to insure no unnecessary or undue degradation of lands.

See the attached Map 1.0 for a visual representation of the exploration area. Public access to the area is currently from 3V Road.

ACC proposes the following seed mixes for reclamation of all lands disturbed during the mining process.



Good Morning,

After reviewing the disturbance area and soils associated, NRCS concurs with the Hayland and Rangeland seeding mixtures selected for reclamation. The nurse crop seeding rate meets NRCS standards, as we recommend a max of 15 pounds/acre for wheat. NRCS recommends clipping the nurse crops before they become competitive with the perennial species.
